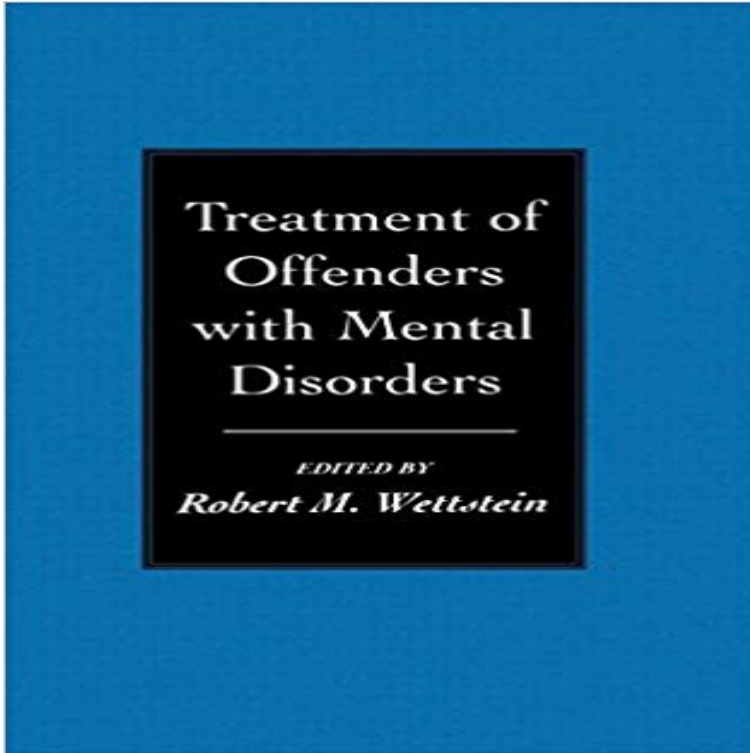


Treatment of Offenders with Mental Disorders
